The Applicant has filed this Notice of Intent for the installation of new drainage structures from the roadway in the area in front of 520 Glen Road cross-country to the rear yard area of 520 Glen Road. A portion of the work falls within the 25-foot No-Disturb Zone and the 100-foot Wetland Buffer Zone.

- For participants calling in on a phone, press \*9 to raise the hand icon
- The chat function has been disabled
- Participants do not have the ability to change their name while in the meeting
- Anyone who is seen holding up signs will have their video disconnected
- Anyone who is seen making rude or disruptive gestures will have their video disconnected
