I. **Approval of Minutes – December 10, 2019**

II. **Residents' Concerns:**

Weston resident Lise Revers came to the Board to present her concern with an ongoing issue at 390 Highland Street and her abutting property at 412 Highland Street. The recent activities at the property concerns her as it is now up for sale. She wants the Board to be aware of the dumping of demolition debris and the piles of it that abut her property and she's concerned that with the sale of the property that it'll be left and no clean up will occur as the material is now ending up on her property and causing water issues as well. Ms. Revers presented copies of pictures and documents about the ongoing issues associated with the property. Public Health Director Wendy Diotalevi will do a site visit by the end of the week.

Emergency Preparedness: Upcoming Trainings

- Shelter Drill: The Local Emergency Planning Committee (LEPC) will be hosting a three hour just-in-time training on March 20, 2020 from 9am-12pm at the Weston Community Center to a select group of Town employees. The training will be run by Weston Emergency Reserve Corp (WERC) members who will have employees observe the set-up of a small shelter.
- Homeowner's Workshop: This workshop will be held March 31, 2020 at the Community Center from 6pm-7:30pm. Town Departments including the Board of Health, Building Dept., Conservation, DPW, and the Fire Dept. will provide presentations that will focus on home safety, maintenance and the process of permitting projects involving septic systems, home upgrades and repairs, drainage, etc. All are welcome to learn and ask questions.
- Shelter Drill: A second shelter drill will be hosted by WERC on Saturday, April, 11, 2020 at the Weston Community Center. This drill will be open to all WERC members and those in the community who would like to participate. This drill will incorporate a behavioral health component.

- Spring Fling & MYCHIP Events: This year the Spring Fling event will be held on Saturday, April 25, 2020 from 10am-2pm on the Town Green. The Masonic Youth Child Identification Program (MYCHIP) will also take place up in the Weston Town Hall Auditorium.
